

<u>Terms and Conditions for One Plus 6T on Amazon with Axis Bank Credit and Debit Cards</u> (15th December 2018- 24th December 2018)

Offer Terms and Conditions:

- Offer 1: Instant discount of INR 1,500 on purchase of One Plus 6T smartphones ("Product") using Axis Bank Cards on Amazon.in (website, mobile site, and app)
