

## Terms & Conditions for Axis Bank Vistara Credit Cards Club Vistara Points & Activation Benefit

- CV (Club Vistara) Points are credited for eligible spend transactions on Axis Bank Vistara Credit Card and issued to cardholder's Club Vistara account every billing cycle, within 10 working days from the statement generation date.
- 2. Any reversal of transaction or conversion of transaction to EMI will lead to reversal of CV Points for the particular transaction.
- 3. Milestone spends and CV points will only be earned on Eligible spends transactions. Eligible spends transactions are defined as spends excluding reversals, fraud transactions, fee payments, cash withdrawals, interest charges, transactions converted to EMI, Fee & other charges, Temporary credit against dispute transaction.
- 4. With effect from, 3<sup>rd</sup> January 2024, spends made towards government services and utilities transactions will not be eligible for earning CV points and milestone benefits.
- With effect from, 20<sup>th</sup> April 2024, spends made towards jewellery and insurance transactions will not be eligible for earning CV points and milestone benefits.
- 6. Any fee or financial charge levied by the Bank is not considered as an eligible transaction for crediting of CV Points or Activation CV Points.
- 7. The following MCCs (Merchant Category Codes) will not be eligible for earning CV points and milestone benefits.

- 8. No CV Points are credited for fuel transactions on Axis Bank Vistara Infinite Credit Card.
- Activation benefit for all Axis Bank Vistara Credit Cards is valid only for the first card membership year. No activation CV Points will be credited for transactions beyond the eligible first 90 days from the card issue date.

- Activation CV Points, if eligible, will be credited to the cardholder's Club Vistara account within
  10 working days of becoming eligible.
- 11. This benefit cannot be combined with any other promotional Offer from TATA SIA Airlines Limited ("TSAL") or Axis Bank Ltd. ("Axis").
- 12. These terms and conditions are in addition to and not in derogation to the terms and conditions as applicable to Club Vistara members, specified on partner website www.airvistara.com, which terms and conditions shall also be applicable in addition to this benefit.
