- 3) Borrowing / Raising funds in Indian Currency / Foreign Currency by issue of debt instruments including but not limited to bonds and Non-Convertible Debentures, in terms of Section 42 of the Companies Act, 2013 read with relevant Rules and the 'Listing Regulations'.
- 4) Convening the 24<sup>th</sup> Annual General Meeting of the Bank and matters related thereto.

Further, please note that the said Audited Financial Results of the Bank will be disclosed to the Stock Exchanges after conclusion of the Board meeting on **Thursday, 26<sup>th</sup> April 2018** and hosted on the website of the Bank on the said date and thereafter published in the newspapers, in accordance with the Listing Regulations.


Please note that the notice of the said meeting for the above purpose is also being uploaded on the website of the Bank and published in the newspapers, in terms of Regulation 46 (2) and 47 (1) of the Listing Regulations.

Further, please note that the restricted trading window (blackout period) for dealing in shares / securities of the Bank will commence from **Thursday, 22<sup>nd</sup> March 2018 and continue up to Saturday, 28<sup>th</sup> April 2018 (both days inclusive)**, in terms of the Share Dealing Code - June 2017, formulated and adopted by the Bank, under the SEBI (Prohibition of Insider Trading) Regulations, 2015.
