## Terms and conditions of auction:-

- Bidder/(s) shall have to give complete offer.

The offers along with the relevant KYC documents and the EMD shall be put in an envelope which should be sealed and super scribed with "Offer from Mr/Ms/ M/s...-----(name of the bidder) for purchase of the Secured Asset(s) / property of Mr. Abhijit Anant Khandewale and the envelope be dropped during normal working hours in the office of the Authorized Officer at Axis Bank Limited, Retail Asset Center, 1st Floor, Mazda Tower, Opp. ZP, GPO Road, Trimbak Naka, Nashik. 422001.
