

Terms and Conditions

- 1. Admizzionz Campuz is providing college admission guidance for courses and colleges in India on the basis of information provided by the applicants and their expressed areas of interest. In case an applicant is not clear about career/course options, the counsellors can guide the applicant on various options in India. The options suggested are not binding on the applicant. The final choice of a career/course is that of the applicant only. However, under no circumstance does this service provide college admission guidance and support for colleges outside India.
- 2. College admission guidance and support for colleges outside India will only be provided if specifically registered for Overseas College Application Services.
- 3. Application Support for colleges with elaborate applications (specifically Liberal Arts Colleges) which include assistance in writing essays, SOP's, answering supplement questions etc will only be provided if registered for Special Application Service for the particular college.
- 4. One Time Counselling (OTC) Service will provide a single interaction with a designated advisor where the queries related to careers and college admissions will be addressed. No further information will be provided after the interaction.
- 5. Assessments conducted at Admizzionz Campuz to assess interests are indicative of the applicant's areas of interest and these are assessed on the basis of the candidate's response at that instant and it may change over time and experience and the results are not binding on the candidate in terms of pursuit of career choice.
- 6. Admizzionz Campuz tries to provide the best fit for an applicant in terms of interest but this does not assure performance of the student once admitted in the college/course. The student will have to study, follow the rules and regulations of the college once admitted and fulfil the course/program/degree requirements to obtain the final certificate/degree.
- 7. After completing the registration process and payment of registration fee for any service, the interactions with the designated advisor will be delivered at Admizzionz Campuz Office (where available)/ Skype / FaceTime / Telephonically as convenient to the applicant.
- 8. Admizzionz Campuz's recommendation of options of courses/institution is solely guided by the interest/options provided by the applicant and the admission criteria of the institutions and previous years data of successful applicants.
- 9. Admizzionz Campuz provides complete admission assistance based on disclosures made by the institution and publicly available information about it, and the best efforts of Admizzionz Campuz to verify the information. Admizzionz Campuz is not responsible for any misinformation or any errors in the information provided.
- 10. Admizzionz Campuz does not guarantee that the options provided are exhaustive.

- 11. Admizzionz Campuz adheres to the admission criteria laid down by the institution. The final decision of granting admission to an applicant rests solely with the institution.
- 12. The admissions cycle could be different for different colleges and the requirements for forms/admissions will be different and the applicant will need to follow the guidelines of the college for filling the admission forms.
- 13. In case any assistance is sought with filling up of forms as part of the admission process, Admizzionz Campuz will try to provide such assistance. However, this service will only be provided when the student or his/her parents/guardians are present along with the AdmizzionCampuz advisor assisting in the process of application filling and it will be their responsibility to check the accuracy of the information being entered. Under no circumstances will Admizzionz Campuz be responsible for the correctness and completeness of data entered. Admizzionz Campuz is also not responsible for any website malfunction during application filling or while making online payments
- 14. It is the responsibility of the applicant to ensure that authentic and correct documents are submitted as required by the institution. Admizzionz Campuz does not verify or certify the documents submitted by the applicant.
- 15. All fees payable to the institutions will have to paid as prescribed by the institution for which admission is sought by a DD or any mode of payment prescribed by the institution favouring the institution. Admizzionz Campuz does not collect fees on behalf of any institution.
- 16. During the admission cycle, it is the sole responsibility of the applicant to maintain the track sheet for applications wherein the important information likelogin Id, password, application number, date of admit card download, date of entrance (if applicable) etc. is stored. Under no circumstances will the designated advisor be responsible to maintain this record.
- 17. All Admissions services enrolled are valid till 30th September of the year the applicant's class XII board exam is held. Extension if requested will be granted at the sole discretion of Admizzionz Campuz subject to payment of a service extension fees.
- 18. In case any refund for the services subscribed is sought, Admizzionz Campuz will initiate the refund as per the refund policy of the company.
