## **Public notice for Sale/E-Auction of immovable properties**

### **{Under SARFAESI Act read with proviso to Rule 8 (6) of the Security Interest (Enforcement) Rules}**

Whereas the Authorized Officer of Axis Bank Ltd. 4. The Bid/(s) need to be submitted above the Reserve Price amount and any bid/(s) received after the due date, time will not be considered as Valid.
5. The tenderer/bidder will have to abide by the rules and regulations of the Local Authority with respect to transfer or use of the said property.
