## Public notice for Sale/Auction of immovable properties {Under SARFAESI Act read with proviso to Rule 8 (6) of the Security Interest (Enforcement) Rules}

Whereas the Authorized Officer of Axis Bank Ltd. ## Terms and conditions of auction:-

- Bidder/(s) shall have to give complete offer.

The offers along with the relevant KYC documents and the EMD shall be put in an envelope which should be sealed and super scribed with "Offer from Mr/Ms/ M/s...-----(name of the bidder) for purchase of the Secured Asset(s) / property of Motiram Kavtikrao Tekale and Sakubai Motiram Tekale and the envelope be dropped during normal working hours in the office of the Authorised Officer at Axis Bank Limited, Retail Asset Center, Mandeep Tower, in Front of Hotel Amarpreet, Jalna Road, Aurangabad 431001.
