

## **Terms and Conditions**

## **Definitions:**

"Contest" shall mean festive reward campaign #BindaasJeeto to educate and encourage consumers for bill payments through Axis Bank's internet and mobile banking platforms, which is Bharat BillPay enabled digital channel:

- "Operating Unit" or "OU" shall mean Axis Bank Limited where the customer holds his/her account for participating in the Contest
- "Biller Categories" shall mean inter alia include the categories of billers as would be included by NBBL as per its sole and absolute discretion
- "Participant" shall mean an Indian citizen who pays his/her utility bills in the Biller Categories

- c. Minimum value of a transaction is Rs. 100
