

# **TERMS AND CONDITIONS- Spend More, Earn More!**

## Campaign/Program Brief:

These terms and conditions ("Terms") shall be applicable to the Cardholder (as defined hereinafter) participating in the Program who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by the Axis Bank. Any Cardholder participating in the Offer/program shall be deemed to have read, understood and accepted these terms and conditions and these terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the Bank.

#### 1. DEFINITIONS

For the purposes of these terms and conditions ("Terms"):

- "Card" shall mean such variants of Axis Bank Forex Cards that have been issued by corporates listed under "Annexure A" and are valid and subsisting during the program period.
- "Card Holder/s" shall mean such Cardholder/s who are existing Axis Bank's Cardholders; and to whom a Card has been issued and who is authorized to hold the Card.
- "Program/Offer Period" shall mean the period commencing from 20<sup>th</sup> January 2020 to 31<sup>st</sup> March 2020 (Both days inclusive) for Offer.
- "Cashback" shall mean funds reloaded to the customer's Forex card by Axis Bank Limited.
- "POS Transaction" shall mean all purchase transactions other than cash withdrawal/Balance Inquiry/Cash at POS
- "Cash at POS" shall mean all transactions where Forex Card is used at merchant outlets (including branches across International Banks) for doing face to face cash disbursement.
- "Eligible customers" shall mean **all Multi-Currency Forex Cardholders** loading/reloading their Forex cards during the campaign period from the corporate channels only via Axis Bank representatives
- "Week" shall mean time from Monday to Sunday (IST time)
- "Day" shall mean time period starting from start of business hours to close of business hours on a Working day and will exclude Sunday & Bank Holiday.
- "Offer" shall mean and include Offers mentioned below.

## 2. OFFER PERIOD - 20th January 2020 to 31st March 2020

- The Offer is valid for all Axis Bank Multi currency Forex Card Holder/s issued by corporates under Annexure A and shall be valid and subsisting during the Program/Offer Period, unless otherwise notified by Axis Bank.
- The offer construct is as follows:

# Offer: Cashback on POS/Ecom transactions

- The offer is valid for Forex cards loaded/reloaded under Business purposes only.
- The offer is valid for customers having Multicurrency Forex cards through the corporate channel only, loading/reloading the card through corporate channel only.
- 10 customers doing highest POS/ECOM transactions during the week (Monday to Sunday) shall be eligible for 10% cashback up to USD 50 equivalent during the offer period.

- Total cumulative amount spent on the card by the customer at POS in the entire week shall be considered for calculating the cashback amount.
- The cashback shall be processed basis the USD (\$) equivalent of the amount in the respective currency. In case of multiple currencies being utilized for POS/Ecom transaction, the currency with the highest amount will be credited with the cashback amount (10% or up to USD 50 equivalent).
- The cross rate for calculating equivalent USD for the above mentioned cash back will be as decided by Axis Bank.
- The cashback will be processed within 30 working days from the end of such month.
- The offer is valid only on successful POS/ ECOM transactions.
- Only settled transactions shall be considered to calculate the total amount spent by the customer for doing POS transactions.
- Transactions reversed due to technical issues and merchant refund shall not be considered for cashback.
- Cash at POS transactions will not be considered as POS transactions and will not be eligible for cashback calculation.

### **General Terms and Conditions**

- Week will be considered as Monday to Sunday. All days including Holidays shall be considered.
- The offer is valid on all Multi currency Forex cards issued through the branch channel only and loaded/reloaded through internet banking (IB), mobile banking (MB), and the branch channel.
- Bank reserves the right to disqualify/ exclude any Card Holder/s from the Offer, if any, fraudulent activity is identified as being carried out for the purpose of availing the benefits under the Offer or otherwise by use of the Card.

### Other Terms and Conditions:

- 1. The benefits under the campaign are neither transferable nor redeemable in cash.
- 2. Bank shall not be liable in any manner whatsoever for any loss/ damage/ claim that may arise out of use of any services availed of by the Card Holder/s under the Offer.

- 4. By participating in this Promotion/Campaign/Offer, the Eligible cardholder agrees to be bound by these Terms and Conditions and the decisions of AXIS Bank shall be final and binding.

- 11. Axis Bank reserves the right to modify/ change all or any of the terms and conditions contained herein as per its discretion without assigning any reasons. Axis Bank also reserves the right to discontinue the Contest/Offer without assigning any reasons. The decision of Axis Bank shall be final in this regard.
- 12. Axis Bank will not be liable in any manner whatsoever for any loss/ damage /claim/injury that may arise due to withdrawal or change in the terms and conditions of the Offer or discontinuation of it.
