



## CBDT Payments through Retail Internet Banking (RIB) of Axis Bank: Shopping Mall

Step 1: To pay CBDT online, visit NSDL site (<http://www.tin-nsdl.com>) > "Services" tab > select "e-payment: Pay Taxes Online"




