Whereas the Authorized Officer of Axis Bank Ltd. **Terms and conditions of auction:-**

- Bidder shall have to give complete offer.
- The bidders have to submit the bid form in a sealed envelope with the details like, (i) full name and particulars of the individual bidder/bidder company/bidder firm/bidder organization (ii) copy of PAN Card (iii) Active Mobile Number (iv) Email Address and (v) Proof of Address.
