

Terms & Conditions for Axis Bank Vistara Credit Cards Maharaja Points & Activation Benefit

- Maharaja Points are credited for eligible spend transactions on Axis Bank Vistara Credit Card and issued to cardholder's Maharaja Club account every billing cycle, within 10 working days from the statement generation date.
- 2. Any reversal of transaction or conversion of transaction to EMI will lead to reversal of Maharaja Points for the particular transaction.
- 3. Milestone spends and Maharaja Points will only be earned on Eligible spends transactions. Eligible spends transactions are defined as spends excluding reversals, fraud transactions, fee payments, cash withdrawals, interest charges, transactions converted to EMI, Fee & other charges, Temporary credit against dispute transaction.
- 4. With effect from, 3rd January 2024, spends made towards government services and utilities transactions will not be eligible for earning Maharaja Points and milestone benefits.
- 5. With effect from, 20th April 2024, spends made towards jewellery and insurance transactions will not be eligible for earning Maharaja Points and milestone benefits.
- 6. Any fee or financial charge levied by the Bank is not considered as an eligible transaction for crediting of Maharaja Points or Activation Maharaja Points.
- 7. The following MCCs (Merchant Category Codes) will not be eligible for earning Maharaja Points and milestone benefits.

- 8. No Maharaja Points are credited for fuel transactions on Axis Bank Vistara Infinite Credit Card.
- 9. Transaction settlement date is considered for calculating milestone and Maharaja Points benefits.
- 10. Activation benefit for all Axis Bank Vistara Credit Cards is valid only for the first card membership year. No activation Maharaja Points will be credited for transactions beyond the eligible first 90 days from the card issue date.

- 11. Activation Maharaja Points, if eligible, will be credited to the cardholder's Maharaja Club account within 10 working days of becoming eligible.
- 12. This benefit cannot be combined with any other promotional Offer from TATA SIA Airlines Limited ("TSAL") or Axis Bank Ltd. ("Axis").
