

### Terms & Conditions for Xiaomi on Axis Bank Credit & Debit Cards

#### Offer Details

**Offer:** Up to INR 1000 cashback with Axis Bank Credit and Debit Cards on Xiaomi products

- Minimum Transaction Amount: INR 10,000
- Maximum Cashback on Axis Bank Credit Cards: INR 1000
- Maximum Cashback on Axis Bank Debit Cards: INR 500
