



## Google Pay app – Axis Bank Offer

These terms and conditions ("Terms") shall be applicable to the User (as defined hereinafter) participating in the offer who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by the Axis Bank ("Bank") through the Google Pay app channel ("Google") only. Any User participating in the Offer shall be deemed to have read, understood and accepted these terms and conditions and these Terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the Bank.

### Definitions:

The following words and phrases shall have the meanings set out herein below in this document unless repugnant to the context:

"Google Pay UPI app shall mean and include the UPI services offered by Google pay to customers of any bank live on UPI who download the app, register on it and create VPA which is linked to a bank account, set UPI PIN against that account and use the App for its various features.

"User" shall mean a person (Axis Bank Accountholder) who registers , links his Axis bank account , makes his/her first successful payment on the Google Pay app within the Offer period will be eligible for the cashback.

"First transaction" shall mean the first ever financial transaction conducted by a Axis bank customer on Google Pay where there is a debit from the Axis account/s of the user. It does not include any other type of transaction conducted on the App by the user.

### Offer:

Add your Axis Bank account to Google Pay and do your first debit transaction of Rs 150 or above and get

1. Rs 50 cashback provided by Axis Bank
2. Scratch card (Amounting to Rs 75 to Rs 150) provided by Google

To be eligible for the cashback:

The user should add the Axis bank account on Google Pay for the first time and do a debit transaction  
The user should not have added Axis bank account to Google Pay earlier. The minimum debit

transaction amount has to be Rs. 150 The registration and the first transaction should be within the Offer Period to be eligible for cashback and scratch card.

3. This offer is non-transferable to any other person and cannot be exchanged with any other offer.
4. Rs. 50 cash back will be given to the end user (Axis bank customer using Google Pay app) instantly. The remaining cashback through scratch card will be credited to the user as per Google tnc (details mentioned at the end) the credit will happen to the customer's account used for making the transaction.
