Whereas the Authorized Officer of Axis Bank Ltd. - Bidder shall have to give complete offer.

- Any disputes / differences arising out of sale of the immovable property (ies) / secured asset(s) offered for sale shall be subject to the exclusive jurisdiction of Courts / Tribunals at Hyderabad only.
