The undersigned is having powers to issue the notice of sale and in exercise all powers of sale under the Act., whereas, the Authorised Officer had issued **Demand Notice dated 07.06.2016** calling upon the borrower(s) and / or guarantor(s) to pay the amount mentioned in the notice being **Rs. 1,34,90,721/- (Rupees One Crore Thirty Four Lakhs Ninety Thousand Seven Hundred and Twenty One only)** being the amount due as on 06.06.2016 (this amount includes interest applied only till 31.03.2016 only) together with future interest, thereon at the contractual rate of interest from 01.04.2016, costs and other consequences, damages etc., including the

4. Bids in the prescribed formats given in the Tender Document shall be submitted "online" through the portal of <https://axisbank.auctiontiger.net>. Bids submitted otherwise shall not be eligible for consideration.
5. The EMD and other payments shall be remitted through EFT / NEFT / RTGS/DD to the bank account as specified above.
6. Bid form without EMD & below the Reserve Price shall be rejected summarily.
7. After the submission of the bid forms, the bidders are not allowed to withdraw the bid forms/EMD, before completion of the e-auction.
