Terms and conditions of <u>auction:-</u>

- 1. Bidder shall have to give complete offer.
- 3. Each tender / Bid/offer shall be accompanied by and Earnest Money Deposit (EMD) equal to 10% of the offer amount (s),by D.D. / Pay Order in favour of 'Axis Bank Limited' payable at Chennai . D.Ds / P.Os should be purchased by the tenderer/bidder or on his/her behalf only.
- 4. Bids received after the due date & time will not be considered.
- 5. The tenderer/bidder will have to abide by the rules and regulations of the Local Authority with respect to transfer or use of the said property.
- 6. As per Section 194 of Income Tax Act (as amended time to time), if property is sold above 50 Lakhs then buyer will have to pay appropriate TDS to the Government treasury and the TDS certificate has to be deposited in the Bank.
- 7. The successful bidder shall deposit 25% of the bid amount (including 10% deposited bid) immediately on the sale being confirmed in his favour. Payment to be made only in the form of Banker's Cheque/DD drawn in favour of **'Axis Bank Limited'** payable at **Chennai**.

The successful bidder shall deposit the balance bid amount within 15 days from the date of confirmation of sale by the Bank. - 9. Inter-se Bidding to all the eligible bidders is The bidder(s) may improve his/their offer(s) by way of inter se bidding among the bidders. The inter se bidding shall commence at the moment of highest bid is opened. The bidder may improve their offer in multiple of the amounts mentioned under the column "Bid Increment Amount". The bidder who submits the highest bid amount (not below the Reserve Price) shall be declared as Successful Bidder and a communication to that effect will be issued to the said highest bidder subject to approval by the Authorised Officer.
- 10. In the event of any default in payment of any of the amounts, or if the sale is not completed by reason of any default on the part of the purchaser within the aforesaid time limit, the Bank shall be entitled to forfeit all the monies paid by the purchaser till then and put up the secured asset(s) / property (ies) for sale/disposal again, in its absolute discretion and may also resale/offer the same to the second highest bidder.
