- 2. A Bidder need to give an Undertaking that he is interested to participate in the bid under present circumstances and will make the complete payment as per SARFAESI timelines.
- 3. The Bid/(s) need to be submitted above the Reserve Price amount and any bid/(s) received after the due date, time will not be considered as Valid.
- 4. The tenderer/bidder will have to abide by the rules and regulations of the Local Authority with respect to transfer or use of the said property.
