## Terms and conditions of auction:-

- 1 Tenderers shall have to give complete offer.
- 2 The borrowers, guarantors and owners of the property under sale may, if they so desire, give his / their or sponsor the best possible valid offer (s) for the property offered for sale provided they follow the requirements herein below.
- 3 Each tender offer shall be accompanied by and Earnest Money Deposit (EMD) equal to 10% of the Reserve Price i.e. Rs 1,50,600/-by D.D. / Pay Order drawn on a Scheduled Bank in favour of 'Axis Bank Limited' payable at Agra/Lucknow.
