

**Power of Attorney**

The Power of Attorney is registrable with Sub-Registrar in case the **POA is executed in India** OR in case the **POA is executed outside India** then the same will be required to be stamped within three months of receiving it in India as per the

Know all Men by These Presents, that

- 1) To operate upon existing Bank A/c's including A/c No/s \_\_\_\_\_ and/or such other bank accounts as may be opened by me/us from time to time and/or operate upon bank accounts on my/our behalf and in my/our name/s sign and endorse all cheques, drafts, slips, bills of exchange, receipts and other negotiable instruments and dividend warrants drawn on and/or in respect and/or to be deposited into the said Account/s and to receive payments in respect of the same, accept and receive money orders and telegraphic transfer of moneys in my/our name/s for the benefit of and/or relating to the said Account/s, and for the said purpose to execute the necessary deeds, documents or transfer deeds of forms.
- 2) To open one or more Savings Account, Current Account, Bank Fixed Deposit and other Term Deposit Accounts in my name and on my behalf in any one or more Banks to discharge, to deposit, pledge, acknowledge and withdraw money and full operate the same, raise loans in my name against such deposits, to execute all or any relevant documents in my name.

- 3) To apply to the Reserve Bank of India and/or any other authority for the operation of the said Account/s and dealing with the moneys lying to the credit of the said account/s and for the purpose to execute any deed, document, writing or application and to do all acts and things required as may be deemed necessary.
- 4) To settle, compound, adjust, compromise or submit to the arbitration all actions, suits, accounts, claims and disputes between me any other person, company, etc. or to compromise the same.
- 5) To concur in doing any one or more of the acts, deeds and things herein before mentioned in conjunction with any other person or persons.

To enter into any agreement for sale, to sell, exchange, surrender, lease or otherwise dispose of any of my property, properties or portion or portions thereof and to transfer, release, any mortgage or change or also to execute or enforce any posters of sale or other powers under any such mortgage or change or otherwise to realize or obtain the benefit thereof in such manner as my said attorney shall think proper.

- 6) To execute and register any document or documents in that behalf.
- 7) To pay for or discharge any debt or debts or any part of them contracted by me or my said Attorney as my said Attorney shall from time to time think proper to pay and discharge.
- 8) To execute, carry into effect and perform all agreements and contracts entered into by me with any other person as my own act and deed and/ or to cancel and/ or to repudiate the same.
- 9) And generally to do, execute and perform any other act or acts, deed or deeds, matter or things whatsoever, which in the opinion of my said attorney ought to be done, executed and performed in relation to my property or my concern engagements and business or affairs ancillary or incidental thereto as fully and effectually as I myself could do the same if I were personally present.

And I hereby agree and undertake to ratify and confirm all and whatsoever my said attorney, under the power in that behalf hereinbefore contained, shall lawfully do, execute or perform in exercised of the power, authorities and liberties hereby conferred upon, under and by virtue of this deed.
