## Terms and conditions of auction:-

• Bidder shall have to give complete offer.

• The bidders have to submit the bid form in a sealed envelop with the details like, (i) full name and particulars of the individual bidder/bidder company/bidder firm/bidder organization (ii) copy of PAN Card (iii) Active Mobile Number (iv) Email Address and (v) Proof of Address.
