Frequently Asked Questions

1. How can I send money via Amazon app?

Open your Amazon App -> Click on Send Money and set up Amazon pay UPI -> Start sending money to your friends & family.

2. How can I avail the cashback?

Send INR 50 or more to your friends/family or pay at your nearby store using any UPI QR code. You will receive INR 50 back as cashback within 2 business days.

3. How many times can I avail this cashback?

This is applicable only once per customer.

4. What are the eligibility conditions for the offer?

You are always eligible for the offer EXCEPT IF (a) you have already availed an existing 25% back up to INR 50 - Shop using Amazon Pay UPI offer on Amazon.in.

5. I do not see Send Money, what should I do?

Send Money is only available on mobile app for Android customers. You must have the latest version of the Amazon app downloaded from the Google Play store in order to access Send Money. You will not be able to use Send Money on desktop, iOS mobile app, tablet or mobile web. If you are not on the latest version, kindly update your app.

6. When and where will the cashback be credited?

Cashback will be credited as Amazon Pay balance within 2 days of the transaction. You can view your available Amazon Pay balance on <http://www.amazon.in/viewstatement>. This Amazon Pay balance is redeemable across products on Amazon.in and partner sites.

Offer Terms and Conditions

1. This limited term promotional offer, namely Send Money Cashback Offer ("**Offer**") is provided to you by Amazon Pay (India) Private Limited ("**APIPL**") and is made available to you on the Amazon mobile application on the Android platform ("**Amazon**").
2. These Offer terms and conditions ("**Offer Terms**") are in addition to Amazon Conditions of Use and Privacy Notice to which you agree to by using Amazon. To the extent the Conditions of Use are inconsistent with these Offer Terms; these Offer Terms shall prevail with respect to the Offer only.
3. This Offer is valid from April 23, 2019 to April 30, 2019 (both days inclusive) ("**Offer Period**"), unless extended or revoked by APIPL in its sole discretion, without any prior notice and without any liability.
4. During the Offer Period, any customer who uses Amazon Pay Unified Payment Interface (UPI) handle available on Amazon ("**Eligible Payment Method**") and undertakes a payment/ money transaction of a minimum value of INR 100 to (a) send money to any UPI handle (such as Amazon Pay, BHIM, PayTM, Google Pay, PhonePe or Bank handles), (b) send money to any Bank account plus IFSC code combination, (c) Scan & Pay to any UPI QR code,

(d) Scan & Pay to any Bharat QR code, (e) Intent transaction, will be eligible to receive cashback of an amount of INR 20. For the avoidance of doubt, it is clarified that the use of the Eligible Payment Method is governed by the applicable terms and conditions, which may be communicated to you at the time of using the Eligible Payment Method.

5. It is clarified that a customer will not be eligible to receive cashback under this Offer: (a) if the payment is made using a payment method other than the Eligible Payment Method; and/ or (b) if a customer pays for incoming collect request either through the Eligible Payment Method or otherwise.
