Whereas the Authorized Officer of Axis Bank Ltd. ## Terms and conditions of auction:-

- Bidder/(s) shall have to give complete offer.
- The bidders have to submit the bid form in a sealed envelop with the details like, (i) full name and particulars of the individual bidder/bidder company/bidder firm/bidder organization; (ii) copy of PAN Card; (iii) Active Mobile Number; (iv) Email Address; and (v) Proof of Address.
