



### **TERMS & CONDITIONS – Fixed Deposit -500 Axis eDGE reward points**

These terms and conditions ("Terms") shall be applicable to the Customer (as defined hereinafter) participating in the offer who agrees to be bound by the same and shall be regulated by the provisions of the specified products and services provided by - Axis Bank- Fixed Deposit creation through Axis Internet Banking and Axis Mobile. Any Customer participating in the Offer shall be deemed to have read, understood and accepted these terms and conditions and these Terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the bank.

#### **Definitions:**

The following words and phrases shall have the meanings set out herein below in this document unless repugnant to the context:

**"Customer"** shall mean Axis Bank savings account holder who are eligible for Axis Bank Service(s) and who has received SMS / email / other communication from Axis Bank with respect to the captioned Offer and who create Fixed Deposit through Axis Internet banking or Axis Mobile.

**"Reward"** shall mean 500 (100 as per current process of booking Fixed Deposit through Axis Mobile /Internet banking and additional 400 for this offer) Axis eDGE Reward points for FD created between communicated duration i.e. within 15 days of communication received and FD created only through Axis Internet banking or Axis Mobile of minimum Rs. 5000/- for 6 months

**"Offer"** shall mean, that the Axis Bank customer who has received communication of this offer and creates FD of Minimum 5000 for 6 months between 17<sup>th</sup> September 2018 to 1<sup>st</sup> October 2018 . Only first 500 customers per day will be eligible for the rewards.

**Offer Period:** As communicated in the Email/SMS/Mobile push notification. Within 15days of communication received. Between 17<sup>th</sup> September 2018 to 1<sup>st</sup> October 2018.

For being eligible for 500 Axis eDGE Rewards campaign the customer needs to create Fixed deposit of minimum Rs. 5000 for 6months through Axis Internet Banking or Axis Mobile between the offer period i.e. on or before 1<sup>st</sup> October 2018.

**Transaction** - means successful Fixed Deposit creation using Axis Mobile| Internet Banking where Amount is successfully debited from account and credited in Fixed deposit account.

#### **Terms of Offer:**

1. The customer needs to have a saving account with Axis Bank and needs to create Fixed deposit of minimum Rs. 5000 for 6months through Axis Internet Banking or Axis Mobile between the offer period.
2. By participating in this offer, Customer agrees to be bound by the terms & conditions of this Campaign including any other applicable terms & conditions modified and prescribed by Axis Bank from time to time. Any such participation by the customer shall imply that the customer has read, understood and accepted the terms and conditions hereunder.

7. Axis Bank shall in no way be liable if any Customer/(s) is/are unable/fail to do the transaction due to incompatible Mobile Phone handsets, Telecom Usage Plans or network failures or for any other reason whatsoever.
8. Customer's eligibility for the offer will be decided by Axis Bank. If certain customers who do the transaction are found to be in-eligible to avail benefits under this campaign will not be given the reward of 500 Axis eDGE Reward points per transaction.
