

Campaign/Program Brief:

These terms and conditions ("Terms") shall be applicable to the Cardholder (as defined hereinafter) participating in the Program who agrees to be bound by the same and shall comply with the provisions of the specified products and services provided by the Axis Bank Limited ("Bank"). Any Cardholder participating in the Offer/program shall be deemed to have read, understood and accepted these terms and conditions and these terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the Bank from time to time.

1. DEFINITIONS

For the purposes of these terms and conditions ("Terms"):

- "Alliance Partner" shall mean vendors providing the gifts/ services Dreamfolks and Amazon
- "Authorized Vendor" shall mean a third party vendor who will be delivering the gifts to the customers.
- "Card" shall mean such variants of Axis Bank Forex Cards that have been issued by Axis Bank and are valid and subsisting during the program period.
- "Card Holder/s" shall mean such Cardholder/s who are existing Axis Bank's Cardholders; and to whom a Card has been issued and who is authorized to hold the Card.
- "Eligible customers" shall mean **All Multi-Currency Forex Cardholders who have been issued a card within the offer period**. The offer is not valid on commercial Forex cards.
- "Gifts" shall mean the discount offered by Alliance Partner.
- "Offer" shall mean and include Offer mentioned below.
- "Program/Offer Period" shall mean the offer period 23rd October 2019 30th November 2019.

2. OFFERS

- The Offer is valid for all Axis Bank Multi currency Forex Card Holder/s and shall be valid and subsisting during the Program/Offer Period, unless otherwise notified by Bank.
- The offer construction shall be as follows:

-As a festive offer all new forex cards loaded during the campaign period with USD 1000 (and equivalent) and above will be eligible for a free F&B airport voucher from Axis Bank

- Everyday starting and inclusive of both dates from 23rd October 2019 30th November 2019 1 top loader of Forex Card will receive an Amazon Echo Dot (a cylindrical voice-controlled computing device that connect to the Alexa Voice Service for providing responses to questions, playing music, reporting on weather, news or sports scores and more)

Process for redeeming the F&B Voucher:

- 1. The Offer is only valid on the Axis Bank Multicurrency Forex Card
- Once the customer loads the Axis Bank Forex Card for Axis Bank will share one time unique ID (valid up to 15th March 2020), pin and URL with their customers through their registered email id only
- 3. Axis will share this code within 4 weeks of loading the forex card
- 4. Once the customer clicks on the URL, co-branded website of Axis Bank will open and they need to fill in below information
 - a. Unique ID and pin
 - b. Full name
 - c. Email id
 - d. Contact no
- 5. Once above information is provided the customer will receive the voucher for F&B combo through email and sms which will be valid for 6 months
- 6. To redeem at the outlet customer needs to open the voucher and click on REDEEM button in front of the cashier– cashier will verify the voucher and eligibility thereof
- 7. Once the outlet barcode is scanned the final E-certificate will be generated which will be active for 5 mins
- 8. The transaction is captured by authentication system and will be shared in the MIS

T&Cs for F&B offer:

- 1. This voucher can only be used by the person whose name is stated at the top of the voucher
- 2. This voucher entitles the bearer to one combo only from the selected outlets as per the eligibility criteria mentioned on voucher detail page
- 3. Please handover the phone to the cashier for redemption, or click on the 'Redeem' button in front of the cashier– cashier will verify the voucher and eligibility thereof
- 4. Once activated, the voucher will be valid for few minutes only. Do not refresh or close the page
- 5. Once redeemed or expired, the voucher will not be refundable or re-activated. This voucher can be redeemed only once
- 6. Outlets available in the program change from time to time. Please check the link in the program details for up-to-date availability
- 7. Combos are strictly subject to availability

T&Cs for winning the Amazon Echo DOT (reward):

- 1. Axis on a T+1 basis will choose the winner of the top loader of the day. Loading can be in any of the 16 currencies of the Forex Card. To come to a common basis to understand the highest loading of any day- loads of the day will be converted to USD.
- 2. In case of same loading of any two or more customers on a given day the card loaded the earliest (time wise) will be awarded the Amazon echo DOT
- Delivery of Amazon Echo DOT will be dispatched to the bank registered address only. Please contact the bank if you wish to change the address. No dispatch shall be made to P.O. Box addresses or to addresses outside India
- 4. The reward will be dispatched 2-3 weeks after the first loading of the Forex Card
- 5. Axis Bank be not held responsible for delay in delivery for reasons beyond our control, such as strikes, natural calamities etc. Products couriered through Speed Post will be delivered in 21 working days. Delivery via speed post might take additional days depending on the remoteness of the address

- 6. Axis Bank reserves the right to cancel the reward won due to stock/ product non availability and other reasons that might affect the product delivery
- 7. The Courier company shall make three attempts to deliver reward ordered to the registered address. If the Reward is not delivered after three attempts, the redemption order stands cancelled and cannot be re-requested

 - i. If the damage is evident from the condition of the packaging, the member should refuse to accept the shipment and obtain a refusal note from the courier company
