

# <u>Terms & Conditions for 2X CV Points Offer on Axis Bank Vistara Credit Cards</u>

These terms and conditions ("Terms") shall be applicable to the Axis Bank Vistara Credit Cardholders (as defined hereinafter) participating in the "Offer" (as defined hereinafter) who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by the Axis Bank ("Axis Bank"). Participation in this offer is voluntary. Any User participating in the Offer shall be deemed to have read, understood and accepted these terms and conditions and these Terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the Bank.

#### **Definitions:**

The following words and phrases shall have the meanings set out herein below in this document unless repugnant to the context:

"Credit Cardholders" - A person who is holding the Axis Bank Vistara Credit Card and who have been communicated the Offer by Axis Bank, OR selected Club Vistara Member who will be communicated the Offer by Club Vistara.

"Axis Bank Vistara Credit Card" means a co-branded card issued by Axis Bank Limited pursuant to cobranded arrangement with Club Vistara.

"Axis Bank Vistara Credit Cardholders" means and include the Credit Cardholders to whom Vistara Credit Cards are issued by Axis Bank Limited.

"Campaign Period/ Offer Period/ Validity" - The period for which the offer is valid.

"Transactions" - any usage on the card which is not a charge/fee/interest levied.

"Merchant" – any establishment where the Axis Bank Vistara credit card mentioned in the offer has been used for making a purchase.

"Parties" - refer to Axis Bank and Club Vistara.

"Bonus CV Points" refer to the incremental CV Points (Club Vistara Points) customer can earn over and above the normal earn rate during the campaign period.

SMS/Email/Mobile App Push Notification sent by Axis Bank to the customer's registered mobile number/email ID mentioning the offer is referred to as "communication". Only those customers who register for the offer are eligible.

The Campaign Period referred to as "Offer Period" or "Validity", used interchangeably, will be the one mentioned in the formal communication received by the cardholder.

To register for the Offer, customer needs to give a missed call on 9966033357 from their registered mobile no. Credit Cardholders would be eligible for 2X CV Points from the date of registration. Spends carried out before the registration date would not be eligible for 2X CV Points. Min spends of Rs.10,000 post registration would be required on a credit card for being eligible for 2X CV Points on that credit card.
