

### Terms and Conditions for 3X Miles Offer on Miles & More Axis Bank Credit Cards

These terms and conditions ("Terms") shall be applicable to the Credit Cardholders (as defined hereinafter) participating in the Offer (as defined hereinafter) who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by the Axis Bank ("Axis Bank"). Participation in this offer is voluntary. Any User participating in the Offer shall be deemed to have read, understood and accepted these terms and conditions and these Terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the Bank.

#### **Definitions:**

The following words and phrases shall have the meanings set out herein below in this document unless repugnant to the context:

"Miles & More" – Miles & More is Europe's leading frequent flyer and awards program run by Miles & More GmbH a 100% subsidiary of Lufthansa Group containing of Austrian Airlines, Brussels Airlines, Swiss Airlines, Eurowings Discover and Lufthansa, the flag carriers of Austria, Belgium, Switzerland and Germany. It is the exclusive loyalty Programme of 9 integrated airlines and partners with 26 airlines from the Star Alliances network.

"Credit Cardholders" – A person who is holding the Miles & More Axis Bank Credit Card (in either version of World or World Select) and who have been communicated the Offer by Axis Bank, OR selected Miles & More Member who will be communicated the Offer by Miles & More.

"Miles & More Axis Bank Credit Card" means a co-branded card issued by Axis Bank Limited pursuant to co-branded arrangement with Miles & More GmbH.

"Miles & More Axis Bank Credit Cardholders" means and include the Credit Cardholders to whom Miles & More Credit Cards are issued by Axis Bank Limited.

"Miles & More membership account" & "Miles & More Service Card Number" is defined as per the Miles & More terms and conditions available at www.miles-and-more.com

"Campaign Period/ Offer Period/ Validity" - The period for which the offer is valid.

"Transactions" – any usage on the card which is not a charge/fee/interest levied.

"Merchant" – any establishment where the Miles & More Axis Bank credit card mentioned in the offer has been used for making a purchase.

"Bonus Miles" refer to the incremental Miles customer can earn over and above the normal earn rate during the campaign period.

Min spends of Rs.10,000 post registration would be required on a credit card for being eligible for 3X Miles on that credit card.
