- 3 Each tender / Bid/offer shall be accompanied by an Earnest Money Deposit (EMD) equal to **Rs.6,40,900/-**. (EMD as mentioned in the chart above), by D.D. / Pay Order in favour of 'Axis Bank Limited' payable at Chennai. D.Ds / P.Os should be purchased by the tenderer/bidder or on his/her/its behalf only.
- 4 The Bid/(s) need to be submitted above the Reserve Price amount and any bid/(s) received after the due date, time will not be considered as Valid.

- 16 The tenderers/ bidders are advised to in their own interest to satisfy themselves with the title and correctness of other details pertaining to the immoveable secured assets including the size/area of the immovable secured assets in question as also ascertain any other dues/liabilities/encumbrances from the concerned authorities to their satisfaction before submitting the tenders/bids.
