## Terms and conditions of auction:-

- 19 The Bank reserves its right to accept or reject highest, any or all offer (s) without assigning any reason and in case all the offers are rejected, either to hold negotiations with any of the tenderers/bidders or to sell the secured asset (s) / immovable property (ies) through private negotiations with any of the tenderers/bidders or any other party / parties.
