## Terms and conditions of auction:-

- 1 Bidder shall have to give complete offer.
- 3 Each tender / Bid/offer shall be accompanied by and Earnest Money Deposit (EMD) equal to 10% of the offer amount (s), by D.D. / Pay Order in favour of 'Axis Bank Limited' payable at Delhi. D.Ds / P.Os should be purchased by the tenderer/bidder or on his/her behalf only.
- 4 Bids received after the due date & time will not be considered.
- 5 The tenderer/bidder will have to abide by the rules and regulations of the Local Authority with respect to transfer or use of the said property.

- 19 The Bank reserves its right to accept or reject highest, any or all offer (s) without assigning any reason and in case all the offers are rejected, either to hold negotiations with any of the tenderers/bidders or to sell the secured asset (s) / immovable property(ies) through private negotiations with any of the tenderers/bidders or any other party / parties.
