

## Earn EDGE REWARD points on Credit Card bills

These terms and conditions ("Terms") shall be applicable to the User (as defined hereinafter) participating in the Offer (as defined hereinafter) who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by Axis Bank ("Bank") through Any User participating in the Offer shall be deemed to have read, understood and accepted these terms and conditions and these Terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the Bank.

### **Definitions:**

Do a credit card bill payment between Rs.10,000 and Rs.25,000	250 <b>EDGE REWARD</b> points
Do a credit card bill payment above Rs.25,000	500 <i>EDGE REWARD</i> points



# Steps to avail the offer

- 1. Any transaction where the user pays their Axis Bank credit card bill using the UPI payment ID cc.91<Your 10 digit registered mobile no.><Last 4 digits of your Credit Card>@axisbank is considered. The EDGE REWARD points will be based on the respective credit card bill payment amounts.
- 2. To be eligible for 250 *EDGE REWARD* points, a user must make a credit card bill payment of a minimum of Rs.10,000 using UPI payment ID during the campaign period. An additional bonus of 250 *EDGE REWARD* points would be credited in case credit card bill payment exceeds Rs.25,000.
- 3. Offer valid only for Axis retail customers. Any transaction done via businesses/ business correspondents or suspicious transactions shall not be eligible.
