

# **Terms & Conditions for**

# **Uber CC Activation Cashback offer for Axis Bank Credit Cardholders**

These terms and conditions ("Terms") shall be applicable to the Credit Cardholders (as defined hereinafter) participating in the Offer (as defined hereinafter) who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by the Axis Bank ("Axis Bank"). Participation in this offer is voluntary. Any User participating in the Offer shall be deemed to have read, understood and accepted these terms and conditions and these Terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the Bank.

#### **Definitions:**

The following words and phrases shall have the meanings set out herein below in this document unless repugnant to the context:

"Credit Cardholders" – A person who is holding the retail Axis Bank Credit Card whose last 4 digits have been mentioned in the communication.

"Communication" – A formal SMS/Mobile app push notification/Email sent by Axis Bank to promote this offer.

"Campaign Period/ Offer Period/ Validity" - The period for which the offer is valid.

"Transactions" – any usage on the card which is not a charge/fee/interest levied.

"Target spend" – The exact amount that the customer needs to spend on his credit card to be eligible for the offer.

"Merchant" – any establishment where the Axis Bank credit card mentioned in the offer has been used for making a purchase.

SMS/Email/Mobile App Push Notification sent by Axis Bank to the customer's registered mobile number/email ID mentioning the offer is referred to as "communication".

The Campaign Period referred to as "Offer Period" or "Validity", used interchangeably, will be the one mentioned in the communication received by customer.



**Offer:** 25% instant discount on 5 Uber rides for each Uber user on select Axis Bank Credit Cards. Maximum discount per transaction will be Rs. 100.

Offer Validity & Promocode will be mentioned in the communication sent by Axis Bank

### How to avail the offer:

- 1. Go to Payments section in the Uber App
- 2. Apply promocode under the promotions tab
- 3. Book your Uber ride and pay with your new Axis Bank Credit Card

### Terms of the offer:

- The offer is valid for only selective Axis Bank Credit Cardholders to whom the formal offer communication via SMS on their registered mobile number has been sent by Axis Bank.
- The Campaign Period referred to as "Offer Period", will be the one mentioned in the communication received by customer through SMS.
- Below are the offer details for the customers. A customer would be eligible for only the offer which was communicated to them by Axis Bank via SMS.
- Offer: Each User shall be entitled to an instant discount of 25% on 5 (five) Uber rides taken by a
  User during the offer period and the payment for such transaction is made through an Axis Bank
  Credit Card.
- The maximum discount that can be availed by a User under the Offer is INR 100 per transaction
- The discount shall be available on the net transaction value of a single transaction. The discount
  is applicable on each single transaction and bills cannot be clubbed to avail the same. The offer
  construct shall be mutually agreed by both the parties.
- Promo Code can be applied under the Promotions tab on the Uber App.
- The offer will be valid during the Promotion Period only which will be at the sole discretion of Uber & Axis Bank.
- Uber & Axis Bank retain the right to change or discontinue the Offer at any time during the Promotion Period without prior notice.
- This Offer cannot be clubbed with any other Axis Bank offer.
- User: The Offer can be availed by any new and existing user of Uber App.
- The offer is not transferable, non-negotiable and cannot be en-cashed.
- Offer is valid for rides taken on Uber App in India only.
- If the invoice amount is more than discount, then the balance will be charged to the payment option selected by the customer on the Uber app, which in this case will be Axis Bank Credit Card. If the invoice amount is less than discount, there will be no refund of the balance amount.
- All customer queries/dispute on the offer should be raised during the Promotion Period or within 90 days after expiry of the Promotion Period. For any disputes, the customer needs to furnish a scanned copy of the charge slip and Invoice for the case to be taken for further investigation.

- Logos/trademarks used are owned by respective entities. Axis Bank has been authorised to use these logos/trademarks for offer promotion purposes.
- The offer by Axis Bank is subject to applicable laws and regulatory guidelines/ regulations and as per bank's extant guidelines from time to time.
