Whereas the Authorized Officer of Axis Bank Ltd. - The Bid/(s) need to be submitted above the Reserve Price amount and any bid/(s) received after the due date, time will not be considered as Valid.
- The tenderer/bidder will have to abide by the rules and regulations of the Local Authority with respect to transfer or use of the said property.

12. Any disputes / differences arising out of sale of the immovable property (ies) / secured asset(s) offered for sale shall be subject to the exclusive jurisdiction of Courts / Tribunals at **Bangalore** only.
