

Do UPI Merchant Transactions & Earn eDGE Rewards

These terms and conditions ("Terms") shall be applicable to the User (as defined hereinafter) participating in the Offer (as defined hereinafter) who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by Axis Bank ("Bank") through Any User participating in the Offer shall be deemed to have read, understood and accepted these terms and conditions and these Terms shall be in addition to and not in derogation of other applicable terms and conditions of any account or any other facility/services offered by the Bank and/or such other terms and conditions as may be specified by the Bank.

Definitions:

The following words and phrases shall have the meanings set out herein below in this document unless repugnant to the context:

"User" shall mean a person who registers, links his/her bank account for UPI transaction on UPI PSPs.

Offer:

Steps to avail the offer

1. User should do a merchant transaction from Axis Bank account via UPI (P2M). (Wallet loads, OD are excluded).

- 2. Offer valid only for Axis retail customers. Any transaction done via businesses/ business correspondents or suspicious transactions shall not be eligible.
- 3. User should complete a set of at least 3 merchant transactions in one of the buckets to be eligible to receive reward points
- 4. On completion 3 successful P2M transactions in at least one of the buckets, the user shall receive the corresponding eDGE Reward points within 10 working days after the completion of the offer period. The eDGE Reward points will be credited within 10 working days after the completion of offer period.

Campaign Period: 1st August 2019 to 31st August 2019 (both days inclusive)

Terms of Offer:
