(1) For any forex transaction where the Bank does not earn any exchange margin, an additional commission of 0.125% in lieu of exchange (CLE) margin will be applicable. This will exclude CLE on inward remittance to be credited to EEFC account. Any outward remittance(not conversion) from EEFC account will be elegible for CLE.

(2) All the above charges will attract Service Tax @ applicable rates as in force from time to time.

(3) Stamp duty charges applicable in the respective states as per Govt. regulations from time to time will be recovered wherever applicable.

(4) Out of pocket expenses in all cases and all charges of foreign correspondent banks will be recovered separately.
