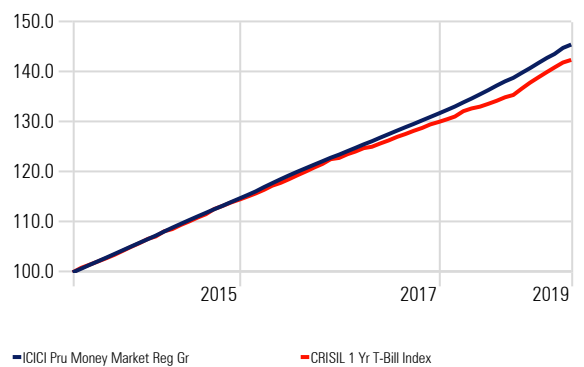

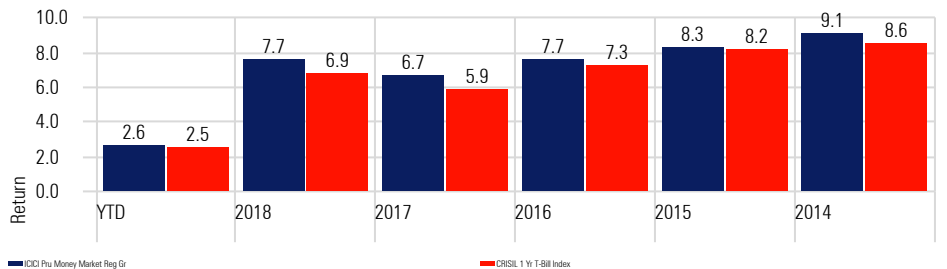
## Investment Growth

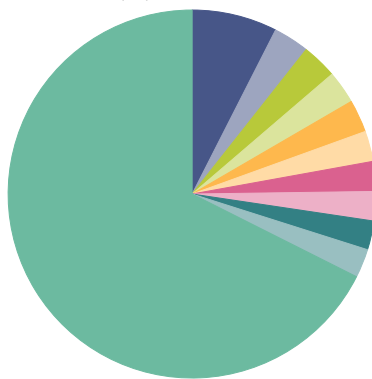

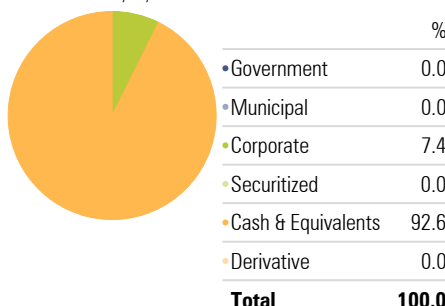
