Electronic copies of the Notice of the AGM and the Annual Report for the financial year 2016-17 have been sent to all the Members whose email IDs are registered with the Bank/ Depository Participant(s). These documents are also available on the website of the Bank, www.axisbank.com. The Notice of the AGM and the Annual Report for the financial year 2016-17 has been sent to all other Members at their registered address in the permitted mode. The dispatch of the Notice of the AGM has been completed on 27th June 2017.
