

#### BHIM AxisPay Registration offer

These terms and conditions ("Terms") shall be applicable to the User (as defined hereinafter) participating in the Offer (as defined hereinafter) who agrees to be bound by the same and shall regulate the provisions of the specified products and services provided by the Axis Bank ("Bank") through the BHIM Axis Pay app (as defined hereinafter). "Link account on Axis Pay for the first time" shall mean customer who has registered on Axis Pay for the first time, created a VPA and linked his/her bank account on Axis Pay for the first time

"Recharge transaction" shall mean the user has used the recharge option available in Axis Pay app to do a successful prepaid mobile or DTH recharge

"BMS" shall mean Book My show a movie, plays, etc ticket booking website/app
