- (a) Through electronic mail, to those Members whose e-mail ID's are registered in the records of the Depository Participant or the Bank's Registrar and Transfer Agent.
- (b) Through physical mode, along with a postage-prepaid self-addressed Business Reply Envelope, to other Members, whose e-mail ID's are not registered, as aforesaid.

The approval of the Members is sought through Postal Ballot, including e-voting, for the following resolution:
