

<u>Terms and Conditions for Targeted Online Spends Campaign on Credit Cards</u>

(20th February 2014 to 20th March 2014)

Terms and Conditions for Credit Card Users

- The offer is valid for only selective Axis Bank Credit Cardholders with active Axis Bank Savings or Current Accounts, to whom the formal offer communication via email and/or SMS on their registered email ID and/or mobile number has been sent by Axis Bank.
- The Campaign referred to as "**Offer Period**", starts from 20th February 2014 and ends on 20th March 2014 (both days inclusive). The card transactions from 00:01 on 20th February 2014 to 23:59 20th March 2014 will only be eligible for this Offer Period.
- Offer: Spend "Rs.X and more" Online using Axis Bank Credit Card (as communicated via Email/SMS on the email ID and/or mobile number registered with Axis Bank) during the Offer Period and get 100% more eDGE reward points
 - o for eg. If as per the product feature of the Credit Card held by the customer, he/she receives 4 eDGE Loyalty Reward points for every Rs 200 spent at a particular merchant category, then under the offer, the customer will receive 8 eDGE Loyalty Reward points (4*2) for every Rs. 200 spent at that merchant category
 - o Offer is valid only on Online purchases i.e. purchase transactions that are made at online merchant websites will be valid under this offer.
 - o Rs.X is the minimum target amount that the customer would need to spend
 - o Only on meeting both of the above two conditions will the customer be eligible for the offer
- Winners of the campaign are those cardholders who spend the threshold amount or more (depending on the offer that has been communicated via Email/SMS on the email ID and/or mobile number registered with Axis Bank) online, during the Offer Period, using their Axis Bank Credit Card.
- If a customer has multiple Credit Cards mapped to a particular card account, the value would be calculated at a sum total of values pertaining to all transactions done on the cards mapped to the card account
- Cardholder's eligibility for the offer will be decided by the Bank.
- The reward points will be credited on the 25th day, after the expiry of the offer period i.e. on April 14th 2014
- All escalations related to this campaign will be valid till 20th June 2014.
