

AXIS BANK MOBILE APPLICATION REGISTRATION CAMPAIGN - October 2015

TERMS AND CONDITIONS

- This campaign is open to all the credit card customers of Axis Bank Credit Card holders who have not registered "Axis Bank Mobile Application" even once before the campaign period (i.e. before 15th October 2015). For the purpose of this campaign, "Credit Card customers" or "Customers" shall mean and include those customers who hold atleast one live credit card of Axis Bank issued until 25th October 2015.
- 2. The customers may or may not have any other relationship with Axis Bank, except mentioned herein-above. For the purpose of this clause, "Any other relationship" shall be defined as holding either a savings bank account and/or a current account and/or NRE/NRO account or having purchased any retail lending product such as Home Loan, LAP, Gold Loan, Personal Loan, Vehicle Loan etc.
