

<u>Terms and Conditions for The Mobile Store 10% discount on Axis Bank Retail Credit Cards</u> <u>Cards</u>

(1st May 2014 to 11th May 2014)

<u>Terms and Conditions for Retail Credit Cards Users</u>

- Offer: 10% discount at The Mobile Store for Axis Bank Cardholders on a single minimum purchase of Rs.15000 per transaction.
- Offer Period: 1st May 2014 to 11th May 2014 (Both days inclusive).
- Maximum discount that can be availed at a transaction level is Rs 2000
- The offer is also applicable on EMI transactions
- The discount will be calculated at transaction level.
- Maximum number of transactions allowed during the offer period is 2 per card
- This Offer is valid on all Axis Bank Retail Credit Cards. This offer is not valid on Corporate Credit Cards

- In one bill customer can purchase maximum two handsets/tablets only.
- Customer has to purchase at least one handset/tablet per invoice besides the following accessories, data cards, EW / TI.
- Each invoice should have minimum 1 handset/tablet and maximum of 2 handsets/tablets
- Offer not valid on the value of Recharges/connections cost added to make the transaction value to Rs 15000 and will not be entitled to instant discount
- This offer is valid on invoice value and not on handset value. I.e. the total amount that gets swiped on the system must be Rs 15000 and above to get offer.
- No part payment either by cash + card or by 2 cards or cheque or Gift voucher or Credit Note, in a single bill will be entitled to instant discount. Bills cannot be clubbed to avail the discount
- Customer has to use single card for the complete transaction (of Rs 15000 and above) in a single swipe, to be entitled for 10% instant discount
